By applying to Daze and using the application, you agree to our privacy policy, and become yourself a knight for the community. Let's make that place a privacy heaven on earth, together.

Our Privacy Policy might change or evolve depending on the law, the way we want to protect our users, or new features we may introduce. Whatever happens, we will always notify our changes by updating the date on the top of this page. Of course, we encourage you to stay up to date with our evolutions and to always be fully aware of the privacy policy of the apps you use.

By using the app, you accept our philosophy and our privacy rules and guidelines. If you ever have any questions concerning those, feel free to contact us. And if for some reasons you don't agree with them anymore, you can deactivate your account, whenever you want.

Informations that we collect :

As you may notice, logging in on Daze requires connecting with Instagram. By doing so, you are giving Daze the access to your Instagram profile using Instagram's API. Hence, you authorise us to access different informations about your account, including your username, bio, pictures, and list of people that you follow, and that follow you (and we have to admit that we are impressed ! 😊 ).

As geolocation is an important part in the Daze experience, we will also need to access to your geographical location when you are using the app.

For obvious reasons (helping you out with your account, make sure everything goes well, keep our algorithm working), we may also collect and keep the personal data that you provide by using the app, such as your name, email, Instagram username, email address, phone number, gender, hometown, city of residence, friends already using Daze, images, songs, personal description, and discovery preferences. For very obvious reasons (security, respect of the guidelines, of privacy, etc) we will also be able to access the content of your conversations happening on Daze. But don't worry, we have no reasons to read them unless they appear to be a threat to the service, people, gouvernement or any national important matter.

As you will be using a phone or tablet to access to Daze, basic informations will also be collected, including the reference of your device's system, your device type and IP address, etc.

How we use it :

As you feel like meeting new people (yes, we know, we are smart ... !), other users will be able to view your app profile, with all the public informations you provided us with. If there's a match, (and we hope there will be thousands), other users will be able to interact with you through the chat, and to see the messages you send them, of course.

Obviously, applicants that are not accepted yet on Daze will not be able to see your profile, or access any of your informations. They will not even be able to know you are using Daze. Thanks privacy!

And of course, you'll not be able to see who's applying neither. To live happy, let's hide away.

The data we collect will help us to make Daze greater. By noticing what seems unclear with analytics, improving our service and features, making it even easier to use, and helping you having the best possible user experience.
